As a part of the quality assurance initiative, IQAC obtains feedback on the curriculum from various stakeholders such as Students/Teachers/Alumni, and Employers for improvement in the curriculum development process.


We have carried out a systematic analysis of the feedback obtained on the curriculum from various stakeholders and would like to present the following highlights for the future curriculum development & Revision process of the university:

- Arts and Commerce courses lack experiential learning exposure and hence require the introduction of mini-projects, practical fieldwork, and internships at the end of the semester or during the summer and winter breaks.
- More open elective options need to be provided to encourage interdepartmental and interdisciplinary learning.
- Some locally need-based courses/fieldwork should be introduced in Social Science-related courses.
- Courses on AI, Digital Marketing, Content Marketing need to be introduced in the Curriculum for Employability.
- In PG courses, subject-specific skill-based activities should be introduced at the end of each semester so that students will get more exposure to in-demand skills for employment/entrepreneurship.

I hope these points will be useful, and you will consider them for the future curriculum delivery process.

- Arts and Humanities programs should be accompanied by Basic IT Skill courses.
- Commerce-related programs should be provided with a few specializations such as Digital Marketing, Finance and Accounting, and Computer Applications.
- More open elective options need to be provided for encouraging interdepartmental and interdisciplinary learning across all branches of Arts and Commerce, etc.
- Some locally need-based courses/fieldwork/University-approved add-on programs should be introduced across all programs based on the theme of community-based learning.
- Industry Internship of 6 months should be made compulsory for courses like BA, B Com, M Com, and MA.
- In PG Courses, students should be availed with a couple of specializations based on open electives and in-demand skills in the current market.
